Concept note

Context & Rationale

On the proposal and thanks to the efforts of the United Nations Committee of Experts on Public Administration (UN-CEPA), the United Nations Economic and Social Council (ECOSOC) has adopted eleven (11) Principles of Effective Governance, as part of the implementation of the Sustainable Development Goals (SDGs) and in particular SDG 16 which calls for “Promoting the advent of peaceful and inclusive societies for the purposes of sustainable development, ensuring access for all justice and establish effective, accountable and inclusive institutions at all levels”.

As fundamental principles, they apply to all public institutions (national, central and subnational), including the executive and legislative branches, the security and justice sectors, the independent bodies established by the Constitution and state enterprises. They are deepened and made operational through a choice of commonly used strategies and related practices, which are an integral and constantly evolving part.

These principles, declined down into some 62 Strategies to support their implementation, constitute a framework of reference and evaluation of institutional capacities and aim to assist the Member States of the international community in their commitment to build Public Institutions, at all levels of governance, effective, accountable and inclusive in order to achieve Sustainable Development.

These Principles are based on 3 fundamental pillars, namely¹:

- 1) Effectiveness:** It is based on and assumes the promotion of the Principle of Competence, Sound Policymaking, and Collaboration;
- 2) Accountability:** It is based on and assumes the promotion of Integrity, Transparency, and Independent Oversight;
- 3) Inclusiveness:** It supposes the Principles of Leaving No One Behind (LNOB), the Non-Discrimination, the Participation, the Subsidiarity, and the Intergenerational Equity.

The World We Want embodied by the 2030 Agenda for Sustainable Development as well as the other Agendas dealing with climate change, the New Urban Agenda, the Sendai Framework for Disaster Risk Reduction as well as the Agenda for Addis Ababa Action, is also consistent with the Seven (7) Aspirations of the African Union's Agenda 2063, including a prosperous Africa based on inclusive growth and sustainable development.

On another side, the African Charter on the Values and Principles of Decentralization, Local Governance and Local Development is based on a set of Core Values, among which: Community-based participation and Inclusiveness, Solidarity, Respect of Human Rights; Diversity and Tolerance, Justice, Equality and Equity, Integrity, Civic responsibility and citizenship, Transparency and Accountability, and Responsiveness.

Among all the Public Institutions, it is the Local and Regional level of Governance which represent the appropriate level where the Principles of Effective Governance can be best implemented, where the political Leaders of these entities can show, on a daily basis, their commitment to these Principles, where Citizens observe and judge the way Local/Regional Public Institutions are led, directed and managed and how they function, where one can see the results and the real impact of Effective Governance concerning the kind of Leadership, the Governance, the operation, and the delivery of public services. Finally, it is at this level that Local Public Institutions can, through their commitment to the principles of Effective Governance as well as to the respect for these Principles, gain the trust of citizens, users, service providers and partners.

UCLG Africa, through its African Local Government Academy(ALGA) would like to take the opportunity and global space of UCLG World Congress to organize a Session on “**Promoting the Principles of Effective Governance in Africa: Peer Learning among African Local and Regional Governments**”, as an opportunity to rise awareness about the cruciality of Effective Governance for Local and Regional Governments (LRGs) not only in Africa, but globally, as a key lever to promote and anchor Decentralization, to enhance Local and Regional Governance, and above all to impact the local and regional development.

Main Objective:

Raising Awareness about the existence of the 11 Principles of Effective Governance adopted by ECOSOC in 2018 and allowing the ownership of such Principles by the LRGs.

Specific Objectives:

- Publicizing, popularizing and disseminating the 11 Principles of Effective Governance among LRGs, in particular in Africa;
- Demonstrating to what extent LRGs in Africa are committed to implementing and anchoring Effective Governance in their vision, leadership and governance;
- Sharing on the best way to create a supportive, facilitating and enabling environment for the implementation of these Principles at Local and Regional level;
- Exploring niches of collaboration with UCLG World Secretariat and its Regional Sections on the Principles of Effective Governance;
- Identifying training and capacity building needs in this area.
